Technical Assistance for Student Assignment Plans

THE TASAP GRANT:

- ◆ A one-time competitive grant
- ◆ **Grant period:** 2 years
- ◆ **Purpose:** Provide for procuring technical assistance in preparing, adopting or modifying, and implementing student assignment plans to avoid racial isolation and resegregation in schools, and to facilitate student diversity, within the parameters of current law.
- ◆ Grant funds are used to seek assistance and expertise from student assignment specialists, demographers, community relations specialists, facility and other planners, or curriculum specialists and others in comparable districts with relevant and successful experience, as well as specialists and consultants from academia, non-profit organizations, civil rights organizations, and the private sector.

THE BPS TASAP PROJECT DESCRIPTION

PROJECT OBJECTIVE

Boston Public Schools will engage with BPS families and community members in a collaborative process to review and identify key characteristics for a student assignment plan that achieves equity and diversity while meeting the needs of families and ensuring that all families have access to high quality programs and schools that ensure academic success.

BACKGROUND

Many of the challenges to reaching and engaging the diverse communities of the city of Boston emanate from the complex historical and political context. Under the Boston TASAP Project, a process will be implemented to consider our current school assignment models, as well as new approaches to addressing the persistent challenges of delivering equitable access to world class education within a racially diverse school system. These challenges include:

- Racially isolating housing patterns,
- Concentrations of underperforming schools in predominantly "minority" neighborhoods,
- Unsustainable rising transportation costs,
- On-going budget challenges.


THE TASAP PROJECT

The plan to achieve these two goals (equity and diversity) is through a community-inclusive process which is advised by the most up-to-date research and best practices. Any new student assignment plan will be developed within the context of current BPS initiatives including the Acceleration Agenda, English Language Learner and Special Education initiatives, Circle of Promise and district restructuring. The development of a new student assignment plan will include examining ways to provide high quality educational programs in every community, prioritize investing funds where most needed, and addressing the underperformance in selected schools.

Boston Public Schools will engage a wide range of community members in this process and we hope to partner with community leaders and organizations to reach and engage all segments of the community, especially those that are traditionally under-represented.

The project begins with **The Golden Opportunity Summit: Exploring Equity-Minded Approaches to Student Assignment and School Reform**, on March 27, 2010, an opportunity to get an overview of recent legal actions around student assignment plans, and a review of national promising practices in student assignment and choice. This venue will be an opportunity for local educators, advocates, community members, parents and leading thinkers and practitioners from across the nation to convene, learn about and discuss student assignment and education reform initiatives in metropolitan Boston. One outcome of this summit will be a written report of summit participant recommendations including: models presented that are likely to be successful in Boston, recommendations on key factors and challenges to consider as decisions are made.

The next phase of the TASAP project is community engagement through a series of facilitated Neighborhood Dialogues throughout Boston's diverse communities. The Summit recommendations will inform this next phase of the project, helping to shape the conversation. Through these conversations, BPS and the community can explore promising student assignment practice in the context of current district strategic initiatives. These meetings will also be an opportunity for BPS to share information and gain feedback about district initiatives.
